



**READY 2 RUN MEETING
APRIL 8, 2006

President

To provide a historical perspective for the club, the Officers are recommending that the Immediate Past President be asked to serve on the board in a voluntary/advisory capacity. There are no revisions necessary to the current bylaws to accommodate this.

Vice President

We had two new members sign up at the trial. They are John & Pat Abbey and Brenda Hill. We currently have 25 individual and 23 family memberships.

Secretary

Nothing to report at this time.

Treasurer

The average annual profit for the past three years has been approx. \$1,900. It is anticipated that this year will be a break even situation. Forecasting for next year, and holding three agility trials (vs. four this year), it is expected there could be a shortfall of approx. \$2,700. A fourth trial could add \$1-2,000 in revenue. Other ideas were discussed as possible ways to increase revenues such as a silent auction at the awards party. This idea will be pursued to determine the feasibility and ensure that it doesn't conflict with PMC donations. The decision as to the fourth trial in 2007 was tabled until after the awards party in August, at which time we will have a better idea how profitable the first three trials of 2006 have been.
