IRONWOOD FACILITY RULES...

1. **NOTE:** We will have ONE designated outdoor arena that we have rented. Details and questions will be handled at the morning briefing.
2. Dogs are to be leashed at all times unless in the ring, or in a designated off-leash area. They are not allowed in any of the staff areas or in the bathrooms.
3. Make sure gates are secure when using any of the outdoor arenas.
4. Horses have the right-of-way. Please do not let your dogs chase or harass the horses.
5. Exhibitors are not to use the dirt planters to potty their dogs. Dogs are to be walked on-leash to the bare dirt, sagebrush areas to potty. If at all possible, do not allow your dogs to potty on any grass.
6. Pick up after yourself and your dogs.
