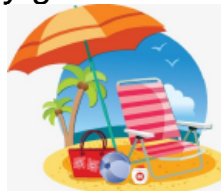
Friday 7:30 AM (or after trailer is unloaded)

WORKERS: Please sign up on the white board by the ring. Remember it's important that everyone pitch in some to help the trial move along smoothly. We will be doing a workers' raffle with lots of fun items to win! *Thanks in advance for volunteering!*

MOVE UPS / DAY OF ADDITIONS: Move up's must be turned into the score table as soon as possible. Additions must be added at the score table before the class you wish to add is finished walking. Day of Show Entries will be \$15.00 per Run.

RIBBONS: Placement and Qualifying ribbons will be self-serve.

NATCH CELEBRATIONS! If you might earn a NATCH at this trial, please let us know, so we can be prepared to celebrate with you presenting a ribbon and a pole (if desired).

HOSPITALITY: We will have a scaled back hospitality table with various individually wrapped snacks as well as bottled water. Beyond snacks and water, please plan on bringing everything you need for you and your dog.

IRONWOOD FACILITY RULES...PLEASE READ CAREFULLY!

- 1. The large outdoor arena will be off limits on Friday AM. Please look for signs directing you to what is available.**
2. When entering an outdoor arena, please confirm that there are no horses and make sure gates are secure. Horses have the right-of-way at all times.
3. Dogs are to be leashed at all times unless in the ring, or in a designated off-leash area. They are not allowed in any of the staff areas or in the bathrooms.
4. Pick up after yourself and your dogs.





JUDGE ' S BRIEFING FROM DENISE GOSIK

Be sure to enter the ring when prompted. You should be set up with your dog on-leash at the first obstacle “before” the next dog is finished.

Wait for judges “Good Luck” at which point you should remove your leash (and don’t forget to remove your dog’s collar as well) and start your run.

Note about Leashes: The leash runner will hand you the leash at the end of your run as the default leash option. This is for trial efficiency. Handlers may still ask for it to be put on the ground or if available on a leash pole or chair. If you would like it on the ground, we will have a marker for the leash runner to place it near the finish (approx. 8’ behind and 8’ to side of finish obstacle). A leash buddy may also be utilized or if desired, *Handlers can continue to pack the leash in their pocket.*

Toys are allowed in the ring at All Levels, but no squeakers or treats. Handlers must declare their intention for training at the beginning before the run is started – just flag the judge with the toy raised before you start.

Training in the Ring is encouraged, in a safe & positive manner. Once training begins you will be Eliminated. You will have a total of 60 seconds total ring time (from when your run began). If you hear the judge say “Thank You” that means you are being asked to stop training and immediately leave the ring.

Start Line Training: once the handler crosses the plane of the first obstacle, if you go back over the plane of the first obstacle you will be given an Elimination fault. If you haven’t crossed the plane of the first obstacle, you are not faulted if you go back to your dog. Do not touch your dog once you’ve left his side.

2022 Changes:

- Teams are no longer given a 5-point fault for nipping/air snapping in the ring. Handler will be given a warning the first time it occurs, and the dog will be given an Elimination any run it occurs thereafter. If contact with skin, clothing, etc. is made it is always an Elimination and depending on the severity of the incident it could be an excusal from the event (even the first occurrence).
- Barrels will no longer be used in the NATCH/Vers-NATCH classes. They will only be in Gamblers and Grounders.
 - Note: Dogs must pass 2 sides of a Barrel for it to be considered an attempt in Gamblers.
